PET PUPPY SALES CONTRACT

This puppy is sold under the following terms and conditions:

This puppy is to the best of the Seller's knowledge a healthy, active puppy at the time of sale, and carries a seven (7) day health and satisfaction guarantee. We suggest that Buyer take the puppy to a veterinarian within the first week for a health examination. If Buyer is not satisfied with the puppy for any reason, it may be returned to the Seller at Buyer's expense during the 7-day period for a full refund, provided the puppy is in the same condition as at the time of sale.

That Buyer guarantees Seller a right of first refusal if the dog is to be sold or disposed of in any way. If at any time you cannot keep, or do not want to keep this dog, you must contact the Seller. Seller will help with placement in an appropriate new home, or take the dog back to care for it until such time as an appropriate new home is found. This provision is to insure the health and welfare of the dog, and to protect the Seller's interest in having dogs of her breeding placed in appropriate homes.

That Buyer will register the dog with a name using the kennel name prefix "Amica".

That the dog will be given appropriate health care during its lifetime, including but not limited to: completion of puppy vaccination series, annual examination and vaccinations, heartworm prevention medication, and internal parasite control.

That the dog will be housed primarily inside the Buyer's home, that the dog will be given adequate and proper food, shade, and water to insure its health, training to make it a suitable family companion, and that it will not be allowed to roam free.

That Buyer will notify Seller of any address change(s) during the life of this dog.

That Buyer will notify Seller immediately if dog is ever lost or stolen, or upon death of the dog.

That this puppy is considered to be a good representative of its breed and is structurally and temperamentally suited as a pet, obedience or hunting companion.

That it is understood that this puppy is sold on Limited Registration, and therefore it may not be shown in AKC sanctioned dog shows in conformation, and any offspring will not be eligible for registration. It may, however, be entered in Obedience, Hunting Tests, Tracking or Agility competition.

That Buyer agrees to have the puppy/dog spayed or neutered by the time it is twelve (12) months of age, and the puppy/bitch spayed or neutered by the time it is six months of age, and will furnish to Seller a letter from Buyer's veterinarian stating this has been done. Buyer agrees this dog will not be bred. These provisions are to protect the welfare of the breed and the Seller's reputation, which would be damaged if the dog were improperly bred.

Every effort has been made to assure this puppy was carefully bred from stock with appropriate health clearances, and therefore reasonable precautions have been taken to prevent this puppy from acquiring hereditary disease. Due to unknown hereditary and environmental causes of such faults, no guarantee can be given that such disease will not occur. If your dog should develop a hereditary disease or defect to the extent that it renders the dog unsuitable to function as a pet, Seller will replace the puppy with another. If the buyer is given another puppy, Seller will not require the Buyer to relinquish the original puppy. This guarantee is good for two years from the date of transfer of this puppy to Buyer.

THE BUYER HAS READ AND UNDERSTANDS THE ABOVE CONTRACT AND TERMS AND AGREES BY SIGNATURE BELOW THAT ALL PORTIONS AND PARTS CONSTITUTE A LEGAL AND BINDING CONTRACT.
